REQUIRED LANGUAGE SKILLS (accepted tests and level)	English Boston University School of Law has a minimum TOEFL requirement of 100 (internet-based) for visiting exchange students, a minimum IELTS score of 7.0 or a minimum ILEC score of B2; however, decisions are made on an individual basis, In the event that a nominated student is not able to arrange to take an English proficiency test, the student should advise BU as soon as possible so that an assessment can be organized by interview.
ENROLMENT/ATTENDANCE FEES TO BE PAID BY VISITING STUDENTS, IF ANY	BU estimates that visiting exchange students for the 2025-2026 academic year will be required to submit financial documentation indicating the availability of funds in an amount of at least \$28,000 for a full-year of study, \$14,000 for a single semester of study in the fall or spring.
INSURANCE INFORMATION (our students are covered by a mobility insurance)	Students must have both medical and accident insurance provided by either the University of origin, according to its own regulations or by an agency authorized to do so.
HOUSING (available options, prices, etc.)	All BU law students live in off-campus housing. The Graduate and International Programs Office will provide students with information on housing options
VISA INFORMATION, if applicable	Incoming exchange students are required to obtain a student visa to remain in compliance with U.S. immigration laws. Upon acceptance into the program, students will be contacted by the BU Law Admissions Office and the University's International Students and Scholars Office (ISSO) regarding the process to obtain a visa. Students are strongly advised to begin the visa application process as soon as they are contacted by those offices.
